# 2025 SKIP-A-PAYMENT

A PROCESSING FEE OF \$39.00 PER SKIPPED LOAN PAYMENT MUST BE RECEIVED BY CHECK OR TRANSFER BEFORE SKIP-A-PAYMENT REQUEST CAN BE PROCESSED.

### For Each Skip-A-Payment:

- Interest will continue to accumulate on each skipped loan
- Loan Payments made through payroll deduction/direct deposit will be deposited into your share account for the skipped month
- All KH Credit Union accounts must be in good standing in order to qualify (upon approval) for Skip-A-Payment
- Signature and Auto Loans are the only loans eligible to be skipped
- Loans opened on or after May 1, 2025 are not eligible.
- Loans may only be skipped once per calendar year
- Loans being skipped must have stayed current for the last 6 months
